

WHO USES THIS FORM

Any erection of signage on a Sanctuary Cove Lot a result of:

- For Sale
- Auction
- Rent
- Any Other

All compliance must be adhered to at all times. If you are found to be in breach of any of the Compliance Criteria set out below, for whatever reason, you will be asked to remove the sign(s) within 24 hours. Failure to remove the sign(s) will result in an external party removing it on your behalf. An additional fee may be payable depending on the nature of the breach.

Sign Layout

TOP THIRD

□ To include in full, the Sanctuary Cove Logo reversed out in blue (PMS 294) background, or vice versa. **MIDDLE THIRD**

□ To include the purpose of the sign, for example, For Sale, For Lease, Auction, Expression of Interest. **BOTTOM THIRD**

To include the Agency name, Agent name and telephone number in Corporate colours (text only, no pictures).

Allowed

- □ No more than two signs (one at the front of the property and one at the back of the Lot).
- An 'Under Offer', 'Under Contract', or 'Sold' tag may be attached to the middle third of the sign.
- An 'Open Home' or 'Auction Date' disc may be attached to the top third of the sign on the right hand side so as not to cover the Sanctuary Cove logo. NB. The disc must fall within the size standards set by the body corporate manager. Please contact Body Corporate Services on 07 5500 3333 for guidance.
- □ Piping allowed, maximum diameter 60mm.

NOT Allowed

- □ No Photographs.
- □ No Fluorescent colours.

Sign Positioning

□ The sign(s) are to be installed within the Lot or on the Lot boundary. The sign(s) can be installed against a fence line.

Installation/Renewal/Removal

- □ Approval is granted for the installation of the sign on the Lot for a maximum of 60 days.
- □ If the sign remains installed on the Lot for more than 60 days a new Application Form must be completed and lodged with Body Corporate Services.
- $\hfill\square$ The sign must be removed from the Lot within 7 days of settlement.
